### CREDIT FACILITY

#### FROM PT BANK HSBC INDONESIA TO PT TEMPO SCAN PACIFIC Tbk

PT Bank HSBC Indonesia ("HSBC") and PT Tempo Scan Pacific Tbk ("Tempo Scan") have signed a loan agreement on 13 December 2018, such an agreement provides a bilateral credit facility between HSBC and Tempo Scan which amount is USD 150,000,000.- (United States Dollars one hundred and fifty million) or equivalent to around Rp. 2,200,000,000,000.- (two trillion two hundred billion Rupiah). Muljadi, Tempo Scan's President Director expressed his appreciation to HSBC which is a global financial institution, for its confidence towards Tempo Scan as an Indonesian private company especially given the current global economic backdrop. Moreover, he said that the said bilateral credit facility will supplement Tempo Scan's internal cash reserve and enable it to undertake acquisition opportunity with larger deal size and/or larger organic investment in its manufacturing and distribution & logistic infrastructures.

Furthermore, he said that what HSBC has done through this credit facility is a proxy of this global financial institution sanguine view towards the burgeoning prospect of the Indonesian economy, and it is a manifestation of HSBC commitment to help companies supporting the Indonesian government strategic initiative to bolster domestic manufacturing capability and logistic infrastructure development.
